

Shinohara 3-Way Turnout

Wiring and Gap Modifications by Didrik A. Voss

The Shinohara 3-Way turnout is a mechanically beautiful turnout but a wiring nightmare. I wanted to use this turnout on my layout with two DPDT switches to control the direction of the points and two sets of bi-color LEDs on my control panel. Bi-color LEDs change from green to red depending on the direction of current flow through the LED. This provides a quick check on the direction of the switch which can be seen from across the room. Unfortunately, wiring the Shinohara 3-Way turnout so that it does short out and shut down the layout proved to be a challenge.

The turnout, as purchased, contains three gaps which are identified as "A", "B", and "C" on the attached diagram. Gaps "A" and "B" are easily located because they are black plastic about 1/8" long. Gap "C" is difficult to spot without a multi-meter. The gap is actually in the frog itself. The fourth gap "D" does not exist in the turnout as purchased but is required to overcome shorting.

First, let's talk about gaps "A", "B", and "C" as the turnout is delivered. Gaps "A" and "C" are unnecessary since the polarity across these gaps never needs to change as will be shown in the attached diagrams. This will be explained later. Gap "B" is a false gap in that continuity across this gap can be traced through the frog to the right of gap "B" and the brass bar across the inner set of points. This brass bar is soldered to the two points and the attached to the throw-bar with a grommet.

Well, how do we solve this problem. Andy Sperandeo's book, "Easy Model Railroad Wiring" has a wiring diagram of a 3-Way turnout (Figure 3-18) which states that only one gap is required. This is actually not true. Two gaps are required. The first gap is labeled "B" in my figure. The second is across the inner points, labeled "D" in my diagram. In fact, Andy shows this gap in his figure but does not discuss it or point it out. Since the polarity of the points is different across the inner points, a gap is required.

Now let's assume we cut the gap "D" across the inner points. I did this by drilling, taping and inserting a small screw through the brass bar across the points and into the plastic throwbar below. Next I cut a gap across the brass bar between the screw and the grommet, then glued in a piece of styrene to insure the gap never closed.

The best way to discuss why gap "D" is required is to review the four positions of the turnout. Please realize the two sets of points can create four sets of conditions, and wiring problems, for the turnout: 1. Down-Down,

- 2. Down-Up, 3. Up-Up, and 4. Up-Down. Wire the turnout as shown in the diagrams. Please realize the wire from the outer set of turnout points has to be wired to two blocks of track. This is due to the unneeded gap "A".
- 1. **Down-Down Route to Track 1**: Every track but the upper (left) track is red in this condition. Prove this to yourself by tracing each wire or track until you hit a gap.
- 2. **Down-Up Route to Track 2**: This is where gaps "B" and "D" become important. The points across the gap "D" brass bar have opposite polarity.
- 3. Up-Up Route to Track 3: In this state, all the tracks are black except the bottom rail leading into Track 3.
- 4. Up-Down Route to Track 3 with Inner Points miss-thrown: This condition can easily happen if a train is coming in from Track 1, reverses and goes out through Track 3. If gap "D" was not in place, a short would occur. This fourth condition is the main reason for cutting the gap at "D". If you never throw the points into this condition, it is possible to wire the turnout as purchased and never have a short. For instance, a 3-position rotary switch could be used which would never allow this condition to occur. Unfortunately, it is very difficult to find a rotary switch that will work. Another approach is to use a set of diodes to control current flow and never allow the inner points to be thrown in the down position when the out points are in the upper position. Using diodes to control the color of the LEDs also started blowing my mind. This seemed like a very complicated, and expensive, approach to overcoming the short. The cheapest and easiest approach was to cut the gap at "D", use two DPDT switches to control the points, and wire in the LEDs as normal. The loose end of the brass bar connecting the points at "D" can be screwed down to the moving cross tie.

A few additional observations from these four conditions.

- 1. The polarity of the gaps "A" and "C" never change across the gaps. This means the gaps are unnecessary.
- 2. The wire feed from the outer points has to be soldered to two rails because of gap "A". That is, the

frog, surrounded by gaps "A", "B", and "C" needs to have a power lead as well as the frog in the lower right of the diagrams.


3. Gap "B" is useless unless gap "D" is cut.

Of course, Shinohara could easily solve this problem by redesigning the turnout as discussed.


December is White Elephant Month




- CHRISTMAS PARTY PROGRAM -

and five maps. This presentation runs about 40 minutes.




Ron has also produced a book and a CD that covers the photos presented in this show.

Riordan, Arthur Byrnes

Arthur Byrnes Riordan, 81, of Kansas City, slipped away peacefully and unexpectedly while reading the Wall Street Journal in his favorite chair Sunday evening, November 9th. He had been in excellent health. Cause of death is thought to be the state of the economy and the recent election. Art was born May 19, 1927, in Flagstaff, Ariz., to Arthur Metz Riordan and Regina Byrnes Riordan. When he was four months old, his father died in a polio epidemic, and his mother brought Arthur and his sister Mary back to her family home in St. Marys, Kan., where he was raised. Just before his eighteenth birthday, he joined the Navy. After basic training he was sent to Officers' Training School at Stanford University. When World War II ended, Art returned to the Midwest and graduated from the University of Kansas with a degree in Business Administration. He was a member of Sigma Phi Epsilon. Art started his manufacturing business, Missouri Valley Plastics, in 1955. In 1963 he became president of Progressive Manufacturing Company in Kansas City, Kan., until moving to Flagstaff in 1970 to take the helm of the Riordan family business, Northern Arizona Gas Service Company. He retired from the company in 1986 to return to Kansas City where he devoted himself to his favorite pastimes, reading and trains. Art's interest in trains began at a very early age when he used to watch them from his window as a child. He became a skilled builder of HO-scale models. His passion took him around the world watching and photographing trains. His vast historical knowledge was highly regarded by enthusiasts across the country, often consulted by editors for factual clarification regarding printed material on railroads. Art kept in close touch with his fellow railroad fans around the country, and was a member of the Union Pacific and Southern Pacific Historical Societies. He leaves behind many good friends who will miss him greatly. Art was a loving father and grandfather who enjoyed celebrating birthdays and holidays with his daughters, grandchildren and his former wife Joanne Alton Riordan. He was a wise, ethical, incredibly generous and non-judgmental man, and a true gentleman. He was known for his great intellect and fairness. His wide-ranging knowledge of world events made him a valued member of family Trivial Pursuit teams. His finely tuned sense of black humor might have been one of his most admired characteristics, perhaps missed most by his daughters, Arden Riordan and Shannon Riordan, both of Kansas City. Art is also survived by his sister, Mary Riordan of Scottsdale, Ariz.; his five grandchildren, Alexander Reusch, Emery Reusch, Nicholas Reusch, Michael Crayton and Laura Crayton -- fine young adults of whom he was very proud; a cousin, Brian Chambers of Flagstaff; and an extended family in Arizona, California and Ireland. Lastly, his beloved feline buddy, Bronko Nagurski will miss him tremendously. There will be a memorial service at 4:30 p.m. followed by a visitation on Saturday, Nov. 15, at D.W. Newcomer's Sons Overland Park Chapel, 8201 Metcalf Ave. In lieu of flowers, a contribution to The Pet Connection, 5918 Broadmoor, Mission, KS, 66202, would honor his memory. Kansas Tourist Railroad

to Test Run Santa Fe Steamer

The Abilene & Smoky Valley Railroad in Abilene, KS will be steaming up former Santa Fe locomotive #3415 for a federal inspection on Dec. 2. A public "sneak preview" is planned for 1:30 that afternoon at the railroad depot, 200 SE 5th, south of the Eisenhower Presidential Library & Museum. 3415 was built in 1919 and was in regular service on Santa Fe's Argentine District out of Kansas City. The railroad donated the locomotive to the city of Abilene in 1954 where it was placed in a public park. In 1996, the city donated it to the Abilene & Smoky Valley where it sat on display until restoration was started in 2005.

Joe Minick, Abilene & Smoky Valley steam engine coordinator, stated that the federal inspection is the next milestone in the path toward regular operations, slated to begin next spring. Minick said that when 3415 was placed in the park, it was in good mechanical condition. Volunteers have performed the majority of the overhaul work. When completed, 3415 will be one of three operational, former Santa Fe steam locomotives and the only operating steam locomotive in the state of Kansas. The railroad plans to run 3415 on special occasions about once a month on its 5 mile long, former Rock Island route via the Smoky Hill River Valley from Abilene to Enterprise. NMRA challenge to DCC sound patent moves forward

The National Model Railroad Association (NMRA) is pleased to report that the United States Patent and Trademark Office (USPTO) determined, after a thorough review of the information submitted by the NMRA, that the NMRA's challenge of the Real Rail Effects Patent on using sound with Digital Command Control was meritorious. The USPTO found in favor of the NMRA on every issue the NMRA submitted for review and is in the process of striking the patent.

Real Rail Effects (RRE) was granted the patent by the USPTO based upon a claim that the technology for using sound with DCC was invented by RRE. The NMRA, with the technical and financial support of a number of DCC manufacturers and hobbyists around the world, filed a challenge to the RRE

Real Rail Effects now has two months in which to file a response to the USPTO's decision. According to USPTO rules for challenges, the NMRA will not be able to respond if RRE chooses to make a response. Nevertheless, the NMRA remains confident that the current decision will remain unchanged even if RRE files a response.
